

**JUDGE PERHACH’S PROCEDURE TO SCHEDULE HEARINGS ON
DISMISSAL MOTIONS FILED BY THE CHAPTER 13 TRUSTEE**

Counsel for the Debtor is responsible for scheduling a hearing when filing an objection to a Chapter 13 Trustee’s motion to dismiss. This procedure only applies to objections to the Chapter 13 Trustee’s motions to dismiss. The Court will not consider “objections” to an opposing party’s Affidavit of Default or Certification of Default and may either summarily overrule or treat them as being without effect. Please refer to the Court’s Uniform Procedure for “Doomsday” Orders if a party has filed an Affidavit of Default or a Certification of Default and you are seeking to dispute the alleged default or enlarge a deadline. The procedure may be found at www.wieb.uscourts.gov/uniform-doomsday-procedures.

If a creditor files a motion to dismiss, the Court will set a hearing on the motion upon the Debtor’s timely objection.

I. FILING THE OBJECTION

1. **DATE AND TIME FOR HEARING:** Use CM/ECF to determine the date and time of the hearing as follows:

a. In CM/ECF, go to Reports and look under Chambers Reports/Functions.

b. Click on “CHAP Chamber Presets.”

c. Choose Judge Perhach from the drop-down menu.

d. This will display a table listing the available presets for Judge Perhach, as of the date that you run the report.

e. Choose a date and time to schedule a hearing based upon the trustee assigned to the case.

i. Choose 9:45 a.m. for Chapter 13 Trustee Rebecca Garcia cases.

ii. Choose 10:30 a.m. for Chapter 13 Trustee Scott Lieske cases.

2. **ADD THE HEARING DATE TO YOUR NOTICE OF HEARING**

a. Once you find the appropriate hearing date and time, add the hearing date and time to your Notice of Hearing. You may also include the language from the notice as part of your Objection document.


The suggested language for the Notice of Hearing is as follows:

PLEASE TAKE NOTICE that a telephone hearing will be held before the Honorable Katherine M. Perhach, United States Bankruptcy Judge, on _____ at _____, to consider the Trustee's Motion to Dismiss this Case. To appear by telephone, you must call the Court conference line at 1-669-254-5252 and enter meeting code 161 0867 0836, passcode 565923 before the scheduled hearing time. Please note that the Court may already be in session, so please wait quietly on the telephone for your case to be called. The Debtors are welcome, but not required to participate in this hearing.

3. **DOCKET THE OBJECTION, NOTICE OF HEARING, AND CERTIFICATE OF SERVICE:**

Once the notice and objection are ready to file, you can follow these instructions to docket the Objection, Notice of Hearing, and Certificate of Service.

- a. Go to the Bankruptcy tab, then select Answer/Response, Reference an Existing Motion/Application and enter the case number.
- b. Make the following selection (**DO NOT SKIP THIS STEP!**):

- c. Pick Objection in the selection menu.
 - d. Select the Filing Attorney.
 - e. Select the Party.
 - f. Attach the PDF of the Objection and add any Attachments to Document

- g. Attach the PDF of the Notice of Hearing and the PDF of the Certificate of Service.

II. TROUBLESHOOTING

1. If you can't find the presets, clear your cache. Instructional videos on how to clear your cache can be found on the Court's website under the “Attorney Resources” tab by clicking on the “Training” subtab.
2. If dates and times appear on the chart, but not for Judge Perhach, the correct Trustee, or the specific matter type needed, this usually means a date has filled up. Please contact Chambers (414-290-2660) and a new date will be provided.

If you are filing after hours, you may leave a message. The dates will be updated on the next business day. You may file an Objection and then separately file a Notice of Hearing once the dates have been updated.
